PUBLICATION ETHICS

The SITA Journal is the official journal of the KUD Industries PN Ltd. - Israel Technology Research Center (<https://www.kudindustries.com>) and Israel Association of Scientists- Newcomers and New Immigrant Engineering Union. It encourages the submission of scholarly and practice-oriented articles in the field of a material, mechanics, and civil engineering, protection of an environment as well. The "Letters in Edition" section gives a tribune for free discussion on actual problems of fundamental and applied scientific researches.

SITA-Journal is designed to reflect current developments and advanced being made in the nanotechnology and ecologically friendly materials .All papers accepted for publication in the Journal will appear simultaneously in both the print journal and online as abstracts.

For all parties involved in the process of publishing (authors, Editorial Board, and reviewers), it is necessary to agree upon standards of expected ethical behavior

Submission declaration and verification

- Authors must certify that their manuscripts are their original work. Plagiarism, Duplicate, Data Fabrication and Falsification, and Redundant Publications are forbidden.
- Authors must certify that the manuscript has not previously been published and is not currently being considered for publication elsewhere.
- If the authors have used the work and/or words of others, the authors must ensure that the work and/or words of others are appropriately cited or quoted and identify all sources used in the creation of their manuscripts.
- When an author discovers a significant error or inaccuracy in his/her own published work, it is the author's obligation to promptly notify the Journal editor or publisher and cooperate with the editor to retract or correct the paper.

Conflict of interest

All authors are requested to disclose any actual or potential conflict of interest including any financial, personal or other relationships with other people or organizations within three years of beginning the submitted work that could inappropriately influence, or be perceived to influence, their work.

Editors and Editorial Board

- The Editorial Board keep information pertaining to all submitted manuscripts confidential.
- The Editorial Board is responsible for making publication decisions for submitted manuscripts.
- The Editorial Board strive to meet the needs of readers and authors.
- The Editorial Board evaluate manuscripts only for their intellectual content.
- The Editorial Board strive to constantly improve their journals.
- The Editorial Board disclose any conflicts of interest and preclude business needs from compromising intellectual and ethical standards.
- The Editorial Board always be willing to publish corrections, clarifications, retractions and apologies when needed.

Review process

Each paper is reviewed by the editor and, if it is judged suitable for this publication, is sent to at least two independent referees for double blind peer review.

- Reviewers must keep information pertaining to the manuscript confidential.
- Reviewers must bring to the attention of the Editor Board any information that may be a reason to reject publication of a manuscript.
- Reviewers must evaluate manuscripts only for their intellectual content.
- Reviewers must objectively evaluate the manuscripts based only on their originality, significance and relevance to the domains of the journal.
- Reviewers must notify the Editorial Board of any conflicts of interest
- Based on reviewer's recommendation, the editor then decides whether the paper should be accepted, revised or rejected.
- Authors obliged to participate in peer review process, to provide retraction or correction of mistakes

Changes to authorship

This policy concerns the addition, deletion, or rearrangement of author names in the authorship of accepted manuscripts:

Before the accepted manuscript is published in an online issue: Requests to add or remove an author, or to rearrange the author names, must be sent to the Journal Manager from the corresponding author of the accepted manuscript and must include:

- The reason the name should be added or removed, or the author names rearranged.
- Written confirmation (e-mail, fax, letter) from all authors that they agree with the addition, removal or rearrangement.
- In the case of addition or removal of authors, this includes confirmation from the author being added or removed. Requests that are not sent by the corresponding author will be forwarded by the Journal Manager to the corresponding author, who must follow the procedure as described above.
- Journal Manager will inform the Journal Editors of any such requests
- Publication of the accepted manuscript in an online issue is suspended until authorship has been agreed.

After the accepted manuscript is published in an online issue: Any requests to add, delete, or rearrange author names in an article published in an online issue will follow the same policies as noted above and result in a corrigendum

Copyright

Articles submitted to the journal should not have been published before in their current or substantially similar form, or be under consideration for publication with another journal. Use this in conjunction with the points below about references, before submission i.e. always attribute clearly using either indented text or quote marks. Authors submitting articles for publication warrant that the work is not an infringement of any existing copyright and will indemnify the publisher against any breach of such warranty. For ease of dissemination and to ensure proper policing of use, papers and contributions become the legal copyright of the publisher unless otherwise agreed.
